† The Editorial Board varied in size from six to nine members. The entire Board was re-elected every two years by the Editorial Committee, with the provision that no more than two incumbents could be replaced at each election. Thus, members normally served several successive two year terms.

‡ The Editorial Committee (until 1948) normally consisted of 15 members elected for six year terms. After 1948, members served five year terms, with three members normally being elected each year. Names are grouped by year of election and arranged, from left to right, in order of the duration of service.
